TERMS AND CONDITIONS: ENROLMENT FEE, TUITION FEE, LEVIES AND CHARGES

A non-refundable once off registration fee is payable per learner on acceptance of enrolment. School fees are compulsory and are payable strictly in advance as per attached Schedule of School Fees, payment, and extras. All tours, school excursions and theatre outings are payable when advised of the event.

I (parent/guardian) also understand the following (in addition to the terms and conditions already accepted):

TERMS AND CONDITIONS FOR ADMISSION

This letter must be signed by the parent(s)/guardian(s) ("Parents"), confirming acceptance of the Terms and Conditions for Admission to Bokamoso Private Primary School ("School").

- 1. Admission to the School is at the discretion of the principal or person delegated in the absence of the principal.
- 2. The school deems good discipline a precondition to quality education. The Parents accept the Disciplinary measures and procedures of the school as described in the Code of Conduct. The school may change and modify the code of conduct from time to time at its own discretion or as deemed necessary. A learner may not refuse any disciplinary sanction. The Parents may not interfere with disciplinary processes. The Parents may not prevent a learner in serving any disciplinary sanction issued. The Parents are obligated to accept the decisions of the principal as final. The Code of Conduct is available for perusal. It contains an appeal mechanism in certain circumstances; however, it is not subject to approval and is not negotiable.
- 3. Learners who are more than two years than the average age of their grade will not be considered for enrolment.
- 4. Parents must provide information on known disabilities of the students.
- 5. Applicants must possess the required level of competence to cope with the school's curriculum.
 - The school reserves the right to conduct a scholastic assessment prior to admitting the applicant. Should a scholastic assessment be required, this will be at the Parents' expense.
- 6. Applications will not be considered unless all the required documentation and information is provided.
- 7. The Parents accept and provide approval to the School for the Principal to arrange random drug tests at his/her discretion.
- 8. The school's medium of instruction is English.
- 9. The prospectus, constitution, rules, regulations, and policies of the school is accepted unconditionally. Any complaints in regards with the must be directed to the principal in writing.
